A RESOLUTION CREATING A TASKFORCE TO SPEARHEAD THE REVIEW AND ASSESSMENT OF THE CITY GOVERNMENT'S PARTNERSHIP WITH THE NAGA CITY PEOPLE'S COUNCIL (NCPC) AND THE VARIOUS GOOD GOVERNANCE PROGRAMS OF NAGA CITY:-

WHEREAS, through Resolution No. 2020-182, the Committee on People Empowerment was tasked to spearhead the review of the partnership between the NCPC and the City Government of Naga as established under City Ordinance 95-092 in order to identify and recommend measures to further strengthen the mandates of the said ordinance and mark the 25th year of this partnership;

WHEREAS, the creation of a taskforce is necessary to formalize and fast-track coordination between the City Government, the NCPC, and other key stakeholders relative to the dictates of the aforesaid resolution;

WHEREAS, the City Government of Naga, aspiring to raise the bar of good governance and cultivate genuine citizen's participation in local governance, realizes the merit of this initiative;

NOW THEREFORE, on motion of the Hon. Ghiel G. Rosales, unanimously seconded;

BE IT RESOLVED to create the *Good Governance Task Force* with the following compositions:

1. Take the lead in the review of the partnership between the City Government of Naga and the Naga City People's Council as enshrined in the People Empowerment Ordinance. Recommend quick actions for consideration of the City Government and the Naga City People's Council;

- 2. Convene separate meetings between the City Mayor and key department heads/offices and the NCPC, and between the Sangguniang Panlungsod and the NCPC to act upon the recommendations from the review of this Taskforce;
- 3. Conduct dialogues with key residents of Naga who are not part of the NCPC on their views on the partnership between the City Government and the NCPC;
- 4. Conduct an assessment of the good governance programs of the City Government and submit its findings and recommendations to the City Mayor and the Sangguniang Panlungsod within 90 days from the approval of this resolution;
- 5. Present recommendations to the City Government and the NCPC on expanding people's participation in local governance for the next 25 years;
- Other functions that may be prescribed by the City Mayor and the Sangguniang Panlungsod by executive order or resolution.

LET COPIES of this resolution be furnished the City Mayor, Hon. Nelson S. Legacion, for his concurrence, all the members of the Good Governance Task Force, and other offices concerned for their information.
